- Post-surgical patients will need an initial visit note before surgery to accurately differentiate residual pain from post-surgical pain
- W/C & Auto Injury patients need all office notes in view of the legality of the injury

We may not prescribe opioids if they are treated with OTC benzodiazepines unless our benzo - caution risk stratification is completed. We offer Naloxone education for all patients. We do not prescribe medical marijuana at SPRC.

Patients on chronic anti-coagulation therapy will be scheduled for spinal injections only after obtaining **written instructions** from prescribing physicians.
